

USING THE DIRECTORY

Directory Format:

- The Table of Classifications on the next page gives the section numbers for each category and the range of numbers in that category. The Table of NAIC codes list the two-digit NAIC code for each category.
- Firms are listed by state, in alphabetical order, in each category.
- An extensive keyword index in the front of the book (page i-1) helps to locate products and services.
- An alphabetical listing of companies (page ii-1) appears at the back of the directory.
- See codes to identify certification and ownership type on the back of the first printed page: "2015 DIR National Minority and Women-Owned Business Directory Forty-Six Edition."

An Example:

If you are looking for a supplier to print a company brochure, first you look up "brochure" in the Keyword Index. You will see that the Keyword Index refers you to the "Printing and Engraving" category. Turning to the "Printing and Engraving" section, you will find suppliers listed alphabetically, according to the state in which they reside. A typical entry might appear as follows:

HISTORY

Diversity Information Resources was founded in Minneapolis in 1968 by H. Peter Meyerhoff, a Honeywell aeronautics engineer, who sought to advance race relations by improving economic conditions for Blacks after the assassination of Dr. Martin Luther King, Jr. Meyerhoff and his wife were European Jews who managed to escape Hitler at the outset of World War II. Themselves victims of discrimination, they were motivated by Dr. King's death to launch the "Buy Black" directory - a 10 page directory of black-owned businesses. In 2001 DIR partnered with SupplierGATEWAY and developed an online Supplier Diversity Database Management Portal. The dynamic portal allows corporations online access to certified minority and women-owned businesses, veteran, service-disabled veteran and HUBZone businesses, supplier registration, certification validation, diversity spend reporting and data cleansing, business matchmaking, tier 2 reporting and vendor prequalification tools (Please contact Diversity Information Resources at (612) 781-6819 or www.diversityinforesources.com for more information). A board of directors, representative of major U.S. corporations sets policy and direction for Diversity Information Resources.

MISSION

To develop, maintain, and provide information resources that enhance supplier diversity initiatives and support the development and economic growth of diverse businesses.

INCLUSION CRITERIA AND LISTING PROCESS

In identifying minority-owned businesses, fifty-one percent of the business must be owned, operated and controlled by minority group members who are U.S. citizens, capable of national and/or regional sales and physically located in the United States or its trust territories. In identifying woman-owned businesses, at least fifty-one percent or more is owned by a woman (or women), who is a U.S. citizen, and who controls the firm by exercising the power to make policy decisions and operates the business by being actively involved in day-to-day management. It must be profit seeking and capable of national and/or regional sales.
